#### About the Position

The Village of Arlington Heights is seeking a customer service oriented Permit Technician for the Building & Life Safety Department. The Permit Technician will support the Department's goal of ensuring structures in Arlington Heights are safe by supporting the coordination of permit applications, inspections, and licensing verification.

In this role, the Permit Technician will perform a wide range of duties while providing excellent customer service by phone, e-mail, and in-person at the front counter of the Department in Village Hall. The Permit Technician will process and review applications for construction permits for completeness and coordinate all aspects of the review process, including performing rudimentary technicial reviews, verifying contractors are properly licensed, and issuing permits. In addition, the Permit Technician will review and process applications for business licenses and certificates of occupancy, and coordinate scheduling of inspections and issuing of certificates.

Successful candidates will have at least a high school diploma, and three years of experience providing excellent customer service in a high-volume environment. Successful candidates will have advanced knowledge of Microsoft Office Suite as well as the ability to learn and use permitting software. Experience in a municipal environment is desirable, but not required. Candidates should hold International Code Council (ICC) Certification as a Permit Technician or have the ability to obtain within one year of hire.

The salary range for this position is \$67,238-\$90,770 with an anticipated hiring range of \$67,238-\$71,007, depending on qualifications and experience. The Permit Technician will work a 37.5 hour work week, and will be offered a diverse and competitive benefits package, including health and dental insurance, paid vacation, and participation in the Illinois Municipal Retirement Fund pension plan.
